TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 31, 2012, and made by **PNC BANK, NATIONAL ASSOCIATION**, ("Agent") to **ALBEA COSMETICS AMERICA, INC.**, a Delaware corporation formerly known as Techpack America, Inc. ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 17, 2010, made by Grantor in favor of Agent (as amended to date and together with all schedules thereto, the "Security Agreement"), a security interest was granted by the Grantor to Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 13, 2011, at Reel 4452 and Frame 0453; and

WHEREAS, Agent now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature, in, to and under the following:

(a) all of the Grantor's trademarks, trademark applications, service marks, trade names and associated goodwill, including those listed on Schedule A hereto (collectively, "Trademarks") And licenses for any of the foregoing ("Licenses"); and


(b) all proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark or Trademark licenses under any License.

2. Release of Security Interest. Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and the other Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in and to the Trademark Collateral. Agent hereby authorizes Grantor or its designee to file this Termination with the United States Patent and Trademark Office.
