**FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS AGREEMENT**

This Full Release and Reconveyance of Security Interests Agreement is granted by ONEVENTURES INNOVATION FUND LP (ABN 98 257 928 031) (the "Secured Party"), having a place of business at Level 2, 18 Bulletin Place, Sydney NSW 200, in favor of BuildingIQ Pty Limited ("BIQ").

WHEREAS, BIQ granted the Secured Party a security interest in all state (including common law), federal and foreign trademarks, service marks and trade names, and applications for registration of such trademarks, service marks and trade names, all licenses relating to any of the foregoing and all income and royalties with respect to any licenses, whether registered or unregistered and wherever registered, all rights to sue for past, present or future infringement or unconsented use thereof, all rights arising therefrom and pertaining thereto and all reissues, extensions and renewals thereof, including the trademarks and service marks listed on the attached Schedule A and registrations and applications therefore identified in Schedule A (hereinafter collectively referred to as the "Trademark Collateral") under that certain General Security Deed dated July 17, 2012 (the "General Security Deed");


WHEREAS, the General Security Deed was recorded with the Trademark Division of the United States Patent and Trademark Office on September 14, 2012, at Reel/Frame 028973/0847 to evidence the security interest granted under the General Security Deed.

NOW, THEREFORE, in consideration of the fulfillment and satisfaction of certain covenants and obligations made by BIQ, and having full authority to do so, the Secured Party hereby forever terminates, releases and discharges the security interest granted in the Trademark Collateral, including such trademarks and service marks identified in Schedule A attached hereto, and reconveys to BIQ, to the extent of its interest therein, the Trademark Collateral, without recourse.
