RELEASE OF ASSIGNMENT FOR SECURITY -- TRADEMARKS

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated December 3, 2010 and that certain Assignment for Security -- Trademarks, dated December 3, 2010 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4434, Frame 0323 on December 15, 2010, GoAmerica Relay Services Corp., a Delaware corporation ("Releasee"), granted to Regiment Capital Special Situations Fund IV, L.P., a Delaware limited partnership ("Releasor"), as administrative agent and collateral agent for certain lenders, a continuing security interest in all right, title and interest of the Grantor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks, all applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Intellectual Property Collateral") including the Intellectual Property Collateral listed on Schedule A attached hereto, to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement); and

WHEREAS, Releasees have requested and Releasor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases, discharges and terminates Releasor's security interest in the Intellectual Property Collateral.
