RELEASE OF ASSIGNMENT FOR SECURITY -- TRADEMARKS

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated December 3, 2010 and that certain Assignment for Security -- Trademarks, dated December 3, 2010 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4434, Frame 0348 on December 15, 2010, Purple Relay Services Co. WHEREAS, Releasees have requested and Releasor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases, discharges and terminates Releasor's security interest in the Intellectual Property Collateral.
