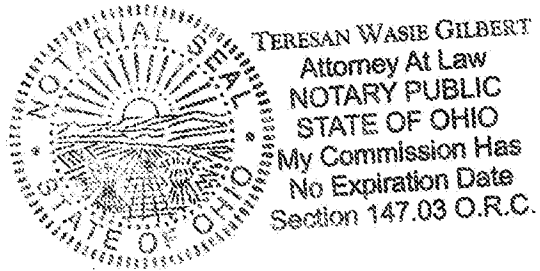

other violation or injury to the goodwill and the right to sue for and recover the same in its own name and that of its successors and/or assigns.

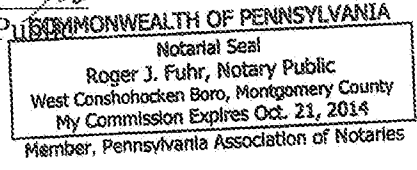
