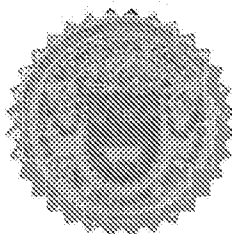

OF

SUNROCK GROUP HOLDINGS CORPORATION
(a New York corporation)

INTO

SUNROCK GROUP HOLDINGS CORPORATION
(a Delaware corporation)

The undersigned corporation, Sunrock Group Holdings Corporation, which is the surviving corporation in the merger described herein, hereby states as follows:

1 The name and state of incorporation of each of the constituent corporations are as follows:

(a) Sunrock Group Holdings Corporation ("Sunrock-NY"), which is incorporated under the laws of the state of New York; and

(b) Sunrock Group Holdings Corporation ("Sunrock-DE"), which is incorporated under the laws of the state of Delaware.

2 An agreement of merger has been approved, adopted, certified, executed and acknowledged by each of Sunrock-NY and Sunrock-DE in accordance with Section 252 of the Delaware General Corporation Law.

3 The name of the surviving corporation is Sunrock Group Holdings Corporation, a Delaware corporation.

4 There are to be no amendments or changes in the certificate of incorporation of Sunrock-DE; and the certificate of incorporation of Sunrock-DE shall be the certificate of incorporation.

5 The executed agreement of merger between Sunrock-NY and Sunrock-DE is on file at Sunrock-DE's offices at 1001 West B Street, Butler, North Carolina, 27509.

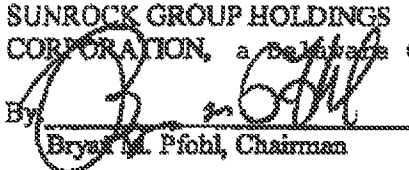
6 A copy of the agreement of merger will be furnished by Sunrock-DE, on request and without cost, to any stockholder of Sunrock-NY or Sunrock-DE.

7 The authorized capital stock of Sunrock-NY is 4,000 shares, consisting of 2,000 common shares having a par value of \$200.00 each and 2,000 preferred shares having a par value of \$100.00 each.
