**CONFIRMATORY GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS AND LICENSED TRADEMARKS**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (as amended, restated, supplemented or otherwise modified from time to time, the "Confirmatory Grant") is made effective as of June 16, 2011 by and from STATION CASINOS LLC, a Nevada limited liability company ("Grantor"), to and in favor of DEUTSCHE BANK AG CAYMAN ISLANDS BRANCH, as Administrative Agent for the Secured Parties (as defined in the Credit Agreement referenced below) (in such capacity, "Grantee").

WHEREAS, Grantor, as borrower, the Lenders and Grantee have entered into a Credit Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, certain Subsidiaries of Grantor have guaranteed the repayment of the Obligations pursuant to a Guaranty Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time).

WHEREAS, Grantor and certain Subsidiaries of Grantor have entered into a Security Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, Grantor owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks are pending or registered with the United States Patent and Trademark Office ("USPTO").

WHEREAS, the Grantor is the licensee of the trademarks listed on Exhibit B attached hereto (the "Licensed Trademarks"), which Licensed Trademarks are pending or registered with the USPTO.

WHEREAS, this Confirmatory Grant has been granted in conjunction with the security interest granted under the Security Agreement to Grantee for the benefit of the Secured Parties.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement.

2) The Security Interest.

(a) This Confirmatory Grant is made to secure the satisfactory performance and payment of all the Obligations. Upon satisfaction of the Release Conditions Grantee shall promptly execute, acknowledge and deliver to the Administrative Agent, and the Administrative Agent shall promptly execute, acknowledge and deliver to Grantor, all reasonably requested instruments in writing releasing the security interest in the Trademarks and Licensed Trademarks acquired under the Security Agreement and this Confirmatory Grant.

(b) Grantor hereby grants to Grantee, on behalf of and for the benefit of the Secured Parties, a security interest in (1) all of Grantor's right, title and interest in and to the Trademarks now owned or from time to time after the date hereof owned or acquired by Grantor, together with (2) all proceeds of such Trademarks, (3) the goodwill associated with such Trademarks and (4) all causes of

action arising prior to or after the date hereof for infringement of such Trademarks or unfair competition regarding the same.

(c) With respect to the Licensed Trademarks, the Grantor hereby grants to Grantee, on behalf of and for the benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in and to the trademark registrations and trademark applications under and to the extent set forth in and permitted by the license to Grantor of such trademark registrations and trademark applications.

3) Interpretation. This Confirmatory Grant and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York. The rights and remedies of Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Security Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

4) Recordation. The parties authorize the Director of the USPTO to record this Confirmatory Grant.
