ASSIGNMENT OF INTELLECTUAL PROPERTY

**RECITALS:**

A. Pursuant to the asset purchase agreement dated December 22, 2010 between the Vendors and Davis + Henderson, Limited Partnership (the "**Original Purchaser**"), (the "**Purchase Agreement**"), the Vendors agreed to sell, assign and transfer to the Original Purchaser and the Original Purchaser agreed to purchase the Purchased Assets, including the Intellectual Property set forth therein;

B. The Original Purchaser assigned the Purchase Agreement to the Purchaser by an assignment agreement dated January 4, 2011 entered into between the Original Purchaser and the Purchaser;

C. Pursuant to the Purchase Agreement, the Vendors agreed to assign to the Purchaser the Vendors' right, title and interest in the Intellectual Property, including the Intellectual Property set out in Schedule "A" hereto;

NOW THEREFORE in consideration of the mutual covenants contained in the Purchase Agreement and in this assignment and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Interpretation** – Unless otherwise expressly provided herein, capitalized terms used herein shall have the meanings attributed to those terms in the Purchase Agreement. This assignment is made pursuant to the Purchase Agreement and to the extent that there is an inconsistency between the terms of the Purchase Agreement and the terms of this assignment relating to matters dealt with herein, the terms of the Purchase Agreement shall prevail.

2. **Assignment of Intellectual Property** – The Vendors, whose postal address is 1551 The Queensway Avenue, Toronto, Ontario M8Z 1T5, hereby sell, transfer and assign to the Purchaser, whose post office address is 939 Eglinton Ave. E., Suite 201 Toronto, ON M4G 4H7, all of the Vendors' right, title and interest in and to the Intellectual Property, including the Intellectual Property set out in Schedule "A" hereto. Without limiting the generality of the

forgoing the Vendors do hereby sell, assign and transfer to Purchaser and Purchaser's successors and assigns, their full and exclusive right, title and interest in the United States of America, Canada and the rest of the world in and to the inventions, patent applications and patents set out in the attached Schedule "A" and the right to file convention applications and all their corresponding right, title and interest in and to any and all patents, and all reissues, divisionals, or reexaminations thereof, which may be issued for the said inventions in United States of America, Canada and the rest of the world and all improvements to the inventions and all patents which may be issued for said improvements in the United States of America, Canada and throughout the world, to have and to hold for the Purchaser's own use and Purchaser's successors and assigns as fully and entirely as the same might be enjoyed by the Vendors if this assignment had not been made.

3. **Further Assurances** – Each of the parties hereto shall promptly do, make, execute or deliver, or cause to be done, made, executed or delivered, all such further acts, documents and things as the other party hereto may reasonably require from time to time for the purpose of giving effect to this assignment and shall use its commercially reasonable efforts and take all such steps as may be reasonably within its power to implement to their full extent the provisions of this assignment or the Intellectual Property from and after the Closing Date. Without limiting the foregoing, with respect to the transfer of domain names listed at Part III of Schedule A, the Vendors shall cause the administrative contact for each domain name to initiate the transfer of the respective domain names to Purchaser within 10 days after the Closing Date.

4. **Enurement** – This assignment shall enure to the benefit of and be binding upon the parties hereto and their successors and assigns.

5. **Governing Law** – This assignment shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.

6. **Counterparts** – This document may be executed in counterparts, each of which shall be deemed to be an original and all of which taken together shall be deemed to constitute one and the same instrument. Counterparts may be executed either in original or faxed form and the parties adopt any signatures received by a receiving fax machine as original signatures of the parties.




