TRADEMARK ASSIGNMENT
(with goodwill)

THIS ASSIGNMENT is made the 20 day of December, 2012.

BETWEEN:

PFIZER HEALTH SOLUTIONS INC., of 235 East 42nd Street, New York, New York 10017, United States of America ("the Assignor")

And

PFIZER INC., of 235 East 42nd Street, New York, New York 10017, United States of America ("the Assignee")

BACKGROUND :

- A. The Assignor is the owner of the trademark and the registration identified in the attached Schedule (hereinafter collectively referred to as "the Trademark").
- B. The Assignor has agreed with the Assignee to assign the Trademark to the Assignee upon the terms and conditions set out in this assignment.

IT IS HEREBY AGREED as follows:

- 1. For good and valuable consideration now paid by the Assignee to the Assignor, the receipt of which is hereby acknowledged, the Assignor ASSIGNS to the Assignee to hold to the Assignee absolutely its entire right, title and interest in and to the Trademark together with the whole of the goodwill associated therewith.
- 2. The Assignor shall at the request and expense of the Assignee execute and do all acts and things as may be necessary or proper to confirm and record the assignment of the rights referred to in clause 1 and the proprietorship of the Assignee therein.
- 3. Pending recordal of the Assignee as the registered proprietor of the Trademark on the relevant Trademark Register, the Assignor agrees to lend its name to any proceedings for infringement of the Trademark, and the Assignee agrees to indemnify the Assignor for all costs and other liabilities incurred by the Assignor arising directly out of such proceedings.


4. The Assignor covenants with the Assignee that it has not done or knowingly suffered or been party or privy to any act or thing whereby it is prevented from validly assigning the rights referred to in clause 1.

5. In this Assignment the expressions "Assignor" and "Assignee" shall, where the context so admits, include their respective successors, heirs and assigns.




