RELEASE OF ASSIGNMENT FOR SECURITY – TRADEMARKS

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of December 3, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") and that certain Assignment of Security – Trademarks dated as of December 3, 2010 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4449, Frame 0186 on January 7, 2011, GoAmerica Relay Services Corp., a Delaware corporation ("Releasee"), granted to Reservoir Capital Partners, L.P., a Delaware limited partnership, as administrative agent and collateral agent for certain lenders ("Releasor"), for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of the Releasee in, to and under the Intellectual Property Collateral, including the Intellectual Property Collateral on Schedule A attached hereto; and

WHEREAS, Releasee has requested and Releasor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing and in exchange for good and valuable consideration, Releasor, on behalf of the Secured Parties, hereby relinquishes, releases, discharges and terminates Releasor's continuing security interest in the Intellectual Property Collateral, including the Intellectual Property Collateral listed on Schedule A attached hereto. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement, as applicable.


