This Certificate of Conversion is filed to convert Solveras, Inc., a Tennessee corporation (the "Corporation"), to Solveras, LLC, a Tennessee limited liability company, pursuant to Section 48-21-111 of the Tennessee Business Corporation Act and Section 48-249-703 of the Tennessee Revised Limited Liability Company Act (the "TLLCA").

FIRST: Prior to its conversion to a domestic LLC, the Corporation was a corporation incorporated under the laws of the State of Tennessee on March 14, 2000. The Corporation was converted to a limited liability company from a corporation.

SECOND: Immediately prior to the filing of the certificate of conversion to a domestic LLC, the name of the former corporation was Solveras, Inc., and its principal business address was 800 Crescent Center Drive, Suite 400, Franklin, Tennessee 37067.

THIRD: The name of the domestic LLC is "Solveras, LLC" as set forth in its articles of organization filed in accordance with Section 48-249-202 of the TLLCA.

FOURTH: All required approvals of the conversion have been obtained by the converting corporation. The terms and conditions of the conversion have been approved by the unanimous vote of the shareholders of the Corporation.

FIFTH: The plan of conversion is attached hereto as Exhibit A.

SIXTH: The number of members of the limited liability company at the date of conversion is one.

SIXTH: The conversion to a limited liability company shall be effective upon filing.

This is a Plan of Conversion for the conversion of Solveras, Inc. a Tennessee corporation (the "Corporation") to a Tennessee limited liability company.

1. The name of the limited liability company into which the Corporation will be converted is Solveras, LLC.
2. The outstanding shares of the Corporation shall be converted into an aggregate of 100 units of membership interest in Solveras, LLC, constituting one hundred percent (100%) of the membership interests in Solveras, LLC.
3. The conversion will be effective upon filing of the Certificate of Conversion.
4. The Articles of Organization of the limited liability company shall read as follows unless and until modified in accordance with the provisions of § 48-249-204:


