**RELEASE OF FIRST LIEN SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This Release ("Release"), dated as of 18th day of December, 2012 is made by Jefferies Finance LLC, in its capacity as collateral agent for the Secured Parties (in such capacity and together with any successors in such capacity, the "Priority Collateral Trustee") pursuant to the First Lien Pledge and Security Agreement, dated as of August 9, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") among the Borrower, Holdings, the other Guarantors from time to time party thereto and the Priority Collateral Trustee.

WITNESSETH

WHEREAS, Grand Haven Developers, LLC, along with other pledgors, is listed on the signature pages to the Trademark Security Agreement (as hereinafter defined), is party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, Grand Haven Developers, LLC ("Grand Haven") executed the Trademark Security Agreement, dated as of August 9, 2012 (the "Trademark Security Agreement"), by and among Grand Haven, the other pledgors and the Priority Collateral Trustee and recorded with the U.S. Patent and Trademark Office on August 9, 2012 at Reel/Frame No. 004839/0471, pursuant to which Grand Haven pledged and granted to the Priority Collateral Trustee for the ratable benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under certain intellectual property owned by Grand Haven identified on Schedule I attached hereto (collectively, the "Grand Haven Trademark Collateral");

WHEREAS, capitalized terms used but not defined in this Release shall have the meaning assigned to such terms in the Security Agreement;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Priority Collateral Trustee agrees as follows:

The Priority Collateral Trustee, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Security Agreement, Trademark Security Agreement, or otherwise, in and to the Grand Haven Trademark Collateral (collectively, the "Released Collateral").

The undersigned authorizes this Release to be filed with the United States Patent and Trademark Office for the purpose of recording the release of the Secured Parties' security interest in the Released Collateral.

IN WITNESS WHEREOF, the Priority Collateral Trustee has executed this Release as of the date first set forth above.
