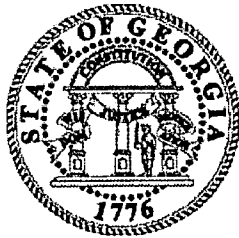

A Small Orange, LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Georgia ("ASO"), desiring to merge its wholly owned subsidiary HostNine LLC, a Florida limited liability company ("Merger Sub") with and into ASO (the "Merger") pursuant to the provisions of the Official Code of Georgia Annotated (the "OCGA"), hereby certifies as follows:

**FIRST:** The name and state of domicile of each of the constituent entities to the Merger (the "Constituent Entities") are as follows:

**THIRD:** ASO will continue as the company surviving the Merger (the "Surviving Corporation") and the name of the Surviving Company shall be A Small Orange, LLC.

**FOURTH:** The merger is to become effective on December 26, 2012.

**FIFTH:** An executed copy of the Agreement and Plan of Merger is on file at the offices of the Surviving Company at 131 Orange Street, Durham, NC 27701, and a copy thereof will be furnished by the Surviving Company, on request and without cost, to any member of the Surviving Company or any member of Merger Sub.

**SIXTH:** The Surviving Company undertakes to deliver a Notice of Merger and a publishing fee of \$40 to an authorized newspaper, as required by Section 14-2-1105.1 of the OCGA.
