TRADEMARK ASSIGNMENT

WHEREAS Damon Schechter, Founder of **LOC GLOBAL LLC**, a California Limited Liability Company, having its principal place of business at 10600 Wilshire Blvd., Suite 214, Los Angeles CA 90024 (hereinafter "ASSIGNOR"), was the owner of U.S. Trademark Registration 3120126 for SHIPWIRE ("the Trademark").

ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to record this assignment against U.S. Trademark Registration 3120126 for

SHIPWIRE and hereby covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
