

OF

MAYA MEDICAL LLC
(a Delaware limited liability company)

WITH AND INTO

COVIDIEN LP
(a Delaware limited partnership)

Pursuant to Section 17-211 of the Revised Uniform Limited Partnership Act of the State of Delaware and Section 18-209 of the Limited Liability Company Act of the State of Delaware

FIRST: The name and domicile of each of the constituent entities is: Maya Medical LLC, a Delaware limited liability company (the "LLC"), and Covidien LP, a Delaware limited partnership (the "Surviving LP").

SECOND: The LLC and the Surviving LP have entered into an Agreement and Plan of Merger, dated as of January 1, 2013 (the "Merger Agreement"), providing for the merger of the LLC with and into the Surviving LP pursuant to Section 17-211 of the Revised Uniform Limited Partnership Act of the State of Delaware (the "RULPA") and Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA"). The Merger Agreement has been approved, adopted, certified, executed and acknowledged in accordance with Section 17-211 of the RULPA and Sections 18-204 and 18-209 of the DLLCA in the case of the LLC.

THIRD: The Surviving LP shall be the surviving entity of the merger and the Limited Partnership Agreement of the Surviving LP shall be its Limited Partnership Agreement.

FOURTH: The Merger Agreement is on file at the offices of the Surviving LP at: 15 Hampshire Street, Mansfield, MA 02048. A copy of the Merger Agreement will be furnished by the Surviving LP, on request and without cost, to any member of the LLC or to any partner of the Surviving LP.

FIFTH: Pursuant to Section 17-206(b) of the Revised Uniform Limited Partnership Act of the State of Delaware, this Certificate of Merger shall be effective at 12:01 a.m. on the 1st day of January, 2013.

IN WITNESS WHEREOF, the Surviving LP has caused this Certificate of Merger to be signed by its duly authorized signatory in its corporate name as of December 27, 2012.
