**GENERAL TRADEMARK AND PATENT ASSIGNMENT**

This General Trademark and Patent Assignment, dated December 31, 2012, by Illinois Tool Works, Inc., a Delaware corporation ("Assignor") with a principal place of business at 3600 West Lake Avenue, Glenview, Illinois, is in favor of La-Co Industries, Inc., an Illinois corporation with offices at 1201 Pratt Boulevard, Elk Grove, Illinois 60007 ("Assignee").

WHEREAS, Assignor and Assignee are parties to an Asset Purchase Agreement dated December 31, 2012 (the "APA"), pursuant to which Assignor has agreed to transfer to Assignee and Assignee has agreed to accept from Assignor, certain Business Intellectual Property (as defined in the APA) of Assignor including:

(A) certain trademark applications and registrations and all rights related thereto, all common law rights therein, and all goodwill in connection thereto, as set forth on Exhibit A, attached hereto (collectively, the "Trademarks");

(B) certain patents, patent applications and registrations and all rights related thereto, including any reexamination, reissue, RCE, divisional, continuation, or continuation-in part thereof that the Assignee may deem necessary or expedient, as set forth on Exhibit B, attached hereto (collectively, the "Patents").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer, and deliver to Assignee:

- (i) of all Assignor's right, title, and interest, in and to the Trademarks and Patents;
- (ii) the goodwill of the business symbolized by the Trademarks;
- (iii) all income, royalties or payments due and payable as of the Closing Date or thereafter with respect to the Trademarks and all causes of actions, claims and demands or other rights for, or arising from, any infringement, dilution, or unauthorized use, including past infringement, of the Trademarks and Patents; and
- (iv) all rights corresponding thereto.

Assignor hereby authorizes and requests the issuing authority to issue any and all Trademarks and Patents to the Assignee.

Assignee, by acceptance hereof, recognizes that this General Trademark and Patent Assignment is subject to the agreements, licenses, and limitations which Assignor has disclosed to it and further recognizes that it is solely responsible for drafting, filing, or recording of any documents necessary to effect or complete the transfer of the Trademarks and Patents, any continuing prosecution and maintenance of the Trademarks and Patents or registrations therefor, and incurring and paying any expenses and fees, including but not limited to legal and government fees and stamp duty. For a period of six months from the date herein, at Assignee's request and expense, and subject to Assignor's review and approval as to form, Assignor will execute documents for the recordal of the assignment of the Trademarks and Patents.

Unless the context shall otherwise require, terms used and not defined herein shall have the meanings set forth in the APA, and all procedures and other provisions set forth in the APA shall govern this General Trademark and Patent Assignment unless otherwise provided herein.

This General Trademark and Patent Assignment shall be binding on the heirs, assigns, representatives and successors of the undersigned and extend to the successors, assigns and nominees of the Assignee.
