## CONTRIBUTION AGREEMENT

THIS AGREEMENT is effective as of 11:59 AM EST on June 29, 2012, by and between ADECCO, INC., a corporation organized and existing under the laws of the State of Delaware (hereinafter referred to as the "Assignor"), and IDEA INTEGRATION CORP., a corporation organized and existing under the laws of the State of Florida (hereinafter referred to as the "Assignee").

### WITNESSETH:

WHEREAS, pursuant to the business reasons outlined in the Board Resolutions dated June 28, 2012, the Board of Directors of each of the entities do deem it advisable, and generally for the welfare of each of the entities and their respective shareholders, to transfer the Idea trademarks at a total fair market value [REDACTED] (as listed on Exhibit A attached hereto) from the Assignor to the Assignee, under and pursuant to the terms and conditions hereafter set forth, as a capital contribution by Assignor to Assignee pursuant to Section 351 of the Internal Revenue Code of 1986, as amended (the "Marks Transfer").


NOW THEREFORE, in consideration of the premises and of the mutual covenants and undertakings of the parties herein set forth, it is agreed as follows:


1. Assignor hereby transfers, assigns, and conveys unto the Assignee all rights, title and interest in and to the Idea trademarks.
2. The parties further agree that all the rights attached to the Idea trademarks are transferred to Assignee. This transfer includes any documentation, description of or materials relating to the trademarks.
3. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Agreement constitutes the entire agreement between the parties pertaining to the subject matter hereof and supersedes all prior agreements and understanding pertaining thereto. This Agreement may be executed in any number of counterparts, all of which together shall constitute one agreement binding on the parties hereto. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Delaware.


