A. Assignee is the owner of the trademarks and trademark applications described on Schedule 1 hereto (the "Trademarks").





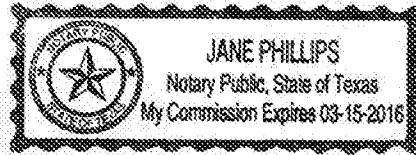
