**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of January 8, 2013, is made by YCCM Finance, LLC, a Nevada limited liability company, in its capacity as Collateral Agent (the "Collateral Agent") pursuant to the Security Agreement, dated as of July 25, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"). WHEREAS, pursuant to the Security Agreement, AquaHydrate executed the Copyright Security Agreement dated July 31, 2012 and filed with the U.S. Copyright Office for recordation, pursuant to which AquaHydrate granted to the Collateral Agent a security interest in and continuing lien on all of its right, title and interest in, to and under the Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, AquaHydrate has requested that the Collateral Agent release its security interest and lien on all of its right, title and interest in and to the Trademark Collateral and the Copyright Collateral.

NOW, THEREFORE, the Collateral Agent hereby RELEASES, without recourse its security interest and lien on all of its right, title and interest in and to the Trademark Collateral and the Copyright Collateral, including the trademark and copyright registrations set forth in Schedule I, attached hereto and incorporated herein by reference.


