**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Houghton Technical Corp., a Delaware corporation (the "Grantor") with principal offices at 945 Madison Ave., Norristown, PA 19403, hereby grants to Royal Bank of Canada, as U.S. Collateral Agent, with principal offices at Royal Bank of Canada, 20 King Street West, 4th Floor, Toronto, ON, M5H 1C4 (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the U.S. Guaranty and Collateral Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; it being understood that with respect to United States intent-to-use trademark applications included in the Trademarks, the grant of the security interest hereunder shall not apply until and unless a statement of use or an amendment to allege use has been filed and accepted by the United States Patent and Trademark Office.

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the U.S. Guaranty and Collateral Agreement among the Grantor, the other assignors from time to time party thereto and the Grantee, dated as of December 20, 2012 (as amended, modified, restated and/or supplemented from time to time, the "U.S. Guaranty and Collateral Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the U.S. Guaranty and Collateral Agreement. The rights and remedies of the parties hereto with respect to the security interest granted herein are as set forth in the U.S. Guaranty and Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the U.S. Guaranty and Collateral Agreement, the provisions of the U.S. Guaranty and Collateral Agreement shall govern. This Grant shall be governed by and construed in accordance with the laws of the State of New York.
