AMENDMENT TO OPERATING AGREEMENT FOR

SITE 5, LLC

NOW KNOWN AS

**WORLD WIDE WEB HOSTING, LLC**  
An Arkansas Limited Liability Company

THIS AMENDMENT TO OPERATING AGREEMENT (the "Amendment") is entered into and effective this 1<sup>st</sup> day of May, 2011, by and among the undersigned, being all of the Members of Site 5, LLC, an Arkansas limited liability company (the "Company").

W-I-T-N-E-S-S-E-T-H:

WHEREAS, the undersigned Members formed this Company pursuant to the Small Business Entity Tax Pass Through Act (Act 1003 of 1993), as amended, hereinafter referred to as the "Act;" and

WHEREAS, Articles of Organization for Site 5, LLC were filed with the Secretary of State on October 3, 2008; and

WHEREAS, an Operating Agreement for the Company was entered into by and between Bweeb, Inc., an Arkansas corporation, and Hostgator.Com, LLC, a Florida Limited Liability Company, as the Members of the Company, with each member holding a 50% ownership interest and voting interest in the Company; and

WHEREAS, the Members of the Company hereby unanimously desire to amend said Operating Agreement, pursuant to Section 6.09 Member Approval Requirements and Section 14.05 Amendments or Modifications, in order to change the Company name as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereby agree as follows:

1. The name of the Company is hereby changed from "Site 5, LLC" to "World Wide Web Hosting, LLC" and a Certificate of Amendment to Articles of Organization for the Company has been or shall be filed with the Arkansas Secretary of State to reflect said name change.

2. All references in the Operating Agreement to "Site 5, LLC" are hereby amended to conform to this change, reflecting "World Wide Web Hosting, LLC" as the new name of the Company.

3. The Operating Agreement is hereby amended and may be restated in its entirety to conform to the foregoing name change pursuant to this amendment.

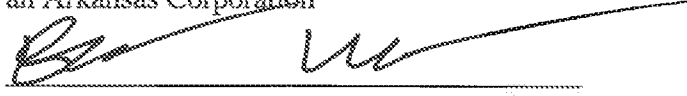
4. All of the terms and conditions of the Operating Agreement, as amended hereby, shall remain in full force and effect.

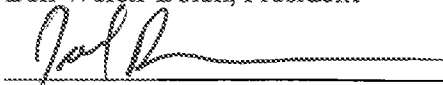
