It is the understanding of the parties that PACINIAN, LLC has previously assigned all rights that it held to the Marks and the Applications and Registrations to PACINIAN CORPORATION pursuant to the AGREEMENT AND PLAN OF CONVERSION executed between PACINIAN, LLC and PACINIAN CORPORATION dated September 12, 2008.


