## ASSIGNMENT OF TRADEMARK

WHEREAS, **Instinet, LLC**, a Delaware Limited Liability Company, having its principal place of business at 1095 Avenue of the Americas, New York, New York 10036 (hereinafter referred to as "ASSIGNOR"), is the owner of the trademarks and the record owner of U.S. Trademarks shown on the attached Schedule A (hereinafter referred to as the "TRADEMARKS");

ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and

enjoyment and the use and enjoyment of its successors, assigns or other legal representatives;  
and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARKS and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument.


