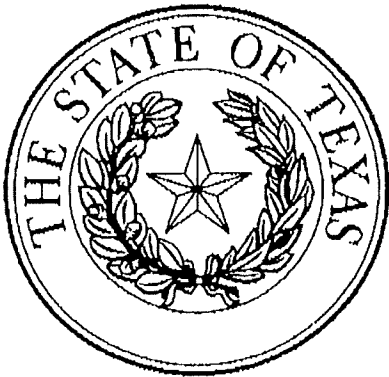

Pursuant to the applicable provisions of the Texas Business Organizations Code, RHYTHM BAND INSTRUMENTS ACQUISITION, LLC, the undersigned limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE 1: ENTITY INFORMATION

1.1 **Name of Filing Entity.** The name of the filing entity is RHYTHM BAND INSTRUMENTS ACQUISITION, LLC.

1.2 **Type of Entity.** The filing entity is a limited liability company.

1.3 **File Number.** The file number issued to the Company by the Secretary of State is 800884253.

1.4 **Date of Formation.** The date of formation of the Company is October 15, 2007.

ARTICLE 2: AMENDMENTS
