TRADEMARK ASSIGNMENT

NOW, THEREFORE, Seller, for and in exchange of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller has sold and does hereby sell, assign, transfer, and convey unto Buyer, its successors and assigns, its entire right, title, and interest in and to the:

- 1) Trademarks, and registrations therefore, all the rights appurtenant thereto, together with the goodwill of the business associated therewith and which is symbolized thereby, all common law rights, all rights to sue for any past infringement or unauthorized use of any Trademarks and to recover all damages therefrom for its own use and behalf and for the use and behalf of its successors and assigns or other legal representatives, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, and in any other jurisdiction, the same to be held and enjoyed by Buyer, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Seller had this Assignment not been made.

Seller agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request and expense of Buyer which Buyer may require in order to transfer all of Seller's right, title and interest in and to the Marks to Buyer, its successors or assigns.

EXCEPT TO THE EXTENT THAT FEDERAL LAW PREEMPTS STATE LAW WITH RESPECT TO THE MATTERS COVERED HEREBY, THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE

STATE OF NORTH CAROLINA WITHOUT GIVING EFFECT TO THE PRINCIPLES OF
CONFLICTS OF LAWS THEREOF.
