

DECLARANT, CYNTHIA R. SMITH, STATES AS FOLLOWS:

1. Declarant is an attorney for Hammond's Candies Since 1920 II, LLC, a Colorado limited liability company, the current owner of Registration No. 1,724,734 for American Candy Company and design (the "Registration").
2. This Declaration pertains to an error in the Trademark Assignment for the Registration from American Candy Company, Inc., a Delaware corporation, to Quality Candy Company, a California corporation, recorded with the Assignment Branch of the US Patent and Trademark Office on February 11, 2003 at Reel/Frame 2607/2404. The Cover Sheet and Assignment incorrectly state American Candy Company, Inc. is an Alabama corporation when, in fact, it is a Delaware corporation.
3. Declarant has examined the relevant records of the Secretaries of State of Delaware and Alabama and the Assignment Branch and determined that:
 - a. The Registration was originally obtained by P.T.C. Brands, Inc. a Delaware corporation, in 1992.
 - b. P.T.C. Brands, Inc. assigned the Registration to ACC Acquisition Company, Inc., a Delaware corporation in 1995, and the assignment was recorded with the Assignment Branch May 1, 1995 at Reel/Frame 1349/0385.
 - c. ACC Acquisition Company was incorporated in Delaware on February 1, 1995 and subsequently changed its name to American Candy Company, Inc. A name change was recorded with the Assignment Branch on June 22, 1998 at Reel/Frame 002062/181.
 - d. American Candy Company, Inc. was a Delaware corporation but it was domiciled in Alabama and was qualified to do business as a foreign corporation in Alabama. It was not an Alabama corporation.
4. Correction of the record is hereby requested. A corrected document is submitted herewith for recording.
