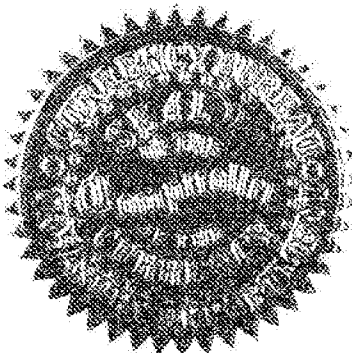

1. The Office of the Comptroller of the Currency, pursuant to Revised Statutes 324, et seq, as amended, and 12 USC 1, et seq, as amended, has possession, custody, and control of all records pertaining to the chartering, regulation, and supervision of all national banking associations.
2. Effective April 24, 1997, the title of "The First National Bank of Boston," Boston, Massachusetts (Charter No. 200), was changed to "BankBoston, National Association."
