## TERMINATION STATEMENT

THIS TERMINATION STATEMENT (this "**Statement**"), dated as of November 20, 2012, is made by Bensalem Holdings LLC, a Delaware limited liability company ("**Secured Party**").

### RECITALS

- A. SUNRx, Inc., a New Jersey corporation (the "**Predecessor**"), has merged (the "**Merger**") with and into Secured Party, effective as of 9:14 a.m. on November 14, 2012 (the "**Effective Time**"). As a result of the Merger, among other things, (i) Secured Party is the surviving entity in the Merger; (ii) the former stockholders and debt holders of the Predecessor are the members of Secured Party; (iii) all properties, rights, privileges, immunities, powers and franchises of the Predecessor are vested in Secured Party; and (iv) all debts, liabilities, obligations and duties of the Predecessor are the debts, liabilities, obligations and duties of Secured Party.
- B. SUNRx, LLC, a Delaware limited liability company ("**Debtor**") and Predecessor entered into that certain Security Agreement, dated as of July 26, 2011 (the "**Security Agreement**"), pursuant to which, among other things, Debtor granted Predecessor a security interest in the Collateral (as defined in the Security Agreement), including, without limitation, (i) certain original works of authorship registered with the U.S. Copyright Office (the "**Copyright Office**") listed on Exhibit A attached hereto and included herein by reference (the "**Copyright Collateral**"); and (ii) certain trademarks and/or services marks registered with the U.S. Patent and Trademark Office (the "**USPTO**") listed on Exhibit A (the "**Trademark Collateral**").
- C. The Security Agreement was recorded at the Copyright Office on August 26, 2011, Confirmation No. of 1-ASXAYV; and recorded at the USPTO on August 25, 2011, at Reel/Frame Number 4611/0377. The certificates of merger evidencing the Merger were recorded at the Copyright Office on \_\_\_\_\_, 2012, Confirmation No. of \_\_\_\_\_; and recorded at the USPTO on \_\_\_\_\_, 2012, at Reel/Frame Number \_\_\_\_\_.
- D. All obligations of Debtor owing to Secured Party have been canceled or otherwise satisfied in full and Secured Party hereby executes and records this Statement to provide public record of the termination and release of Secured Party's security interests in the Collateral including, but not limited to, the Copyright Collateral and the Trademark Collateral.

NOW THEREFORE, Secured Party hereby acknowledges and agrees as follows:

1. Termination and Release of Security Interests. Secured Party, as successor in interest to Predecessor, acknowledges and agrees that all obligations of Debtor owing to Secured Party have been canceled or otherwise satisfied in full and the security interests in the Collateral

granted by Debtor in the Security Agreement have terminated. Secured Party hereby releases any and all security interests it may have in the Collateral and agrees that the security interests granted in the Collateral pursuant to the Security Agreement have no further force or effect.

2. Recordation. This Statement may be recorded at the Copyright Office and the USPTO to evidence the termination and release of Secured Party's security interests in the Copyright Collateral and the Trademark Collateral.



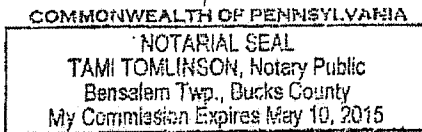
