**TERMINATION STATEMENT
(MedImpact)**

THIS TERMINATION STATEMENT (this "**Statement**"), dated as of November 20, 2012, is made by MedImpact Healthcare Systems, Inc., a California corporation ("**Secured Party**").

RECITALS

- A. SUNRx, LLC, a Delaware limited liability company ("**Debtor**") and Secured Party entered into that certain Security Agreement, dated as of July 26, 2011 (the "**Security Agreement**"), pursuant to which, among other things, Debtor granted Secured Party a security interest in the Collateral (as defined in the Security Agreement), including, without limitation, (i) certain original works of authorship registered with the U.S. Copyright Office (the "**Copyright Office**") listed on Exhibit A attached hereto and included herein by reference (the "**Copyright Collateral**"); and (ii) certain trademarks and/or services marks registered with the U.S. Patent and Trademark Office (the "**USPTO**") listed on Exhibit A (the "**Trademark Collateral**").
- B. The Security Agreement was recorded at the Copyright Office on August 26, 2011, Confirmation No. of 1-ASXAYV; and recorded at the USPTO on August 25, 2011, at Reel/Frame Numbers 4611/0577 and 4611/0532.
- C. All obligations of Debtor owing to Secured Party have been canceled or otherwise satisfied in full and Secured Party hereby executes and records this Statement to provide public record of the termination and release of Secured Party's security interests in the Collateral including, but not limited to, the Copyright Collateral and the Trademark Collateral.

NOW THEREFORE, Secured Party hereby acknowledges and agrees as follows:

1. Termination and Release of Security Interests. Secured Party acknowledges and agrees that all obligations of Debtor owing to Secured Party have been canceled, replaced, exchanged, or otherwise satisfied in full and the security interests in the Copyright Collateral and the Trademark Collateral granted by Debtor in the Security Agreement have terminated. Secured Party hereby releases any and all security interests it may have in the Copyright Collateral and the Trademark Collateral and agrees that the security interests granted in the Copyright Collateral and the Trademark Collateral pursuant to the Security Agreement have no further force or effect.
2. Recordation. This Statement may be recorded at the Copyright Office and the USPTO to evidence the termination and release of Secured Party's security interests in the Copyright Collateral and the Trademark Collateral.

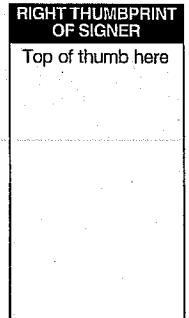
