Wentworth, the assignee of the entire right, title and interest in and to the same, for their sole use and benefit, and for the use and benefit of their successors and assigns, to the full end of the term for which trademark registrations may be granted as fully and entirely as the same would have been held by me had this assignment and sale not been made.
