In accordance with Section 252 of the General Corporation Law of the State of Delaware (the "DGCL"), the undersigned corporation, Dunn-Edwards Corporation, a Delaware corporation, ("Dunn-Edwards Delaware") does hereby certify as follows:

1. The names of each of the constituent corporations of the merger and the laws under which each such corporation was organized are:

2. An Agreement and Plan of Merger dated as of April 9, 2003, between Dunn-Edwards Delaware and Dunn-Edwards Corporation, a California corporation ("Dunn-Edwards California") (the "Agreement of Merger"), has been approved, adopted, certified, executed and acknowledged by Dunn-Edwards Delaware and Dunn-Edwards California in accordance with the requirements of subsection (c) of Section 252 of the DGCL (and, with respect to Dunn-Edwards Delaware, by written consent of its sole stockholder in accordance with Section 228 of the DGCL).

4. The certificate of incorporation of Dunn-Edwards Delaware as in effect at the time of the merger shall be the certificate of incorporation of the surviving corporation.
