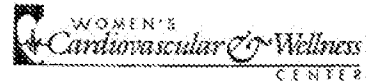


This Service mark Assignment is binding on the Assignors and their respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
