RELEASE AND TERMINATION OF SECURITY AGREEMENT

In consideration of the payment of all indebtedness and amounts secured by that certain Trademark Security Agreement made as of October 17, 2012, by and between MidCap Business Credit LLC, a Texas limited liability company, with a principal place of business at 433 South Main Street, West Hartford, Connecticut 06110 (the "Lender"), and The Adams Bakery Corporation, a Delaware corporation, with a principal place of business at 3300 Walnut Street, Unit C, Boulder, Colorado 80301 (the "Borrower"), which Trademark Security Agreement was filed with the United States Patent and Trademark Office on October 17, 2012, and recorded in Reel 4883, Frame 0028, of the Trademark Assignment Records, the Lender hereby releases and discharges all of its right, title and interest in and to the above-described Trademark Security Agreement, including the security interest and conditional assignment created and existing thereunder on the property described in and covered thereby, and reassigns to the Borrower any right, title and interest of the Lender in and to the "Collateral" described therein, including the right to recover for past infringement of any of the Collateral and the goodwill of the business in connection with which the Collateral is used and which is symbolized by any of the Collateral.

Reference is made to the above-described Trademark Security Agreement and the recordation thereof for all purposes in connection herewith.
