ASSIGNMENT

Any and all other rights and privileges provided under the trademark and other laws of the United States, the individual states thereof, Canada, the individual provinces thereof and all other jurisdictions worldwide with respect to the foregoing including any and all common law rights; the GOODWILL of the business in which the mark EASY TEAMS is used; and any and all renewals thereof, together with the right to bring suit and collect for past infringements thereof.

NOW, THEREFORE, in view of the payment of Ten Dollars (\$10.00), and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor DOES HEREBY assign and transfer to Assignee all right, title and interest in and to the Rights.

Assignor shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in Assignee good, valid and marketable title to the Rights.

This Assignment and all terms hereof shall be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns.
