**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of January 23, 2013 (this "Release"), is made by Societe Generale, as Collateral Agent ("Collateral Agent"), in favor of Airvana Network Solutions Inc. ("Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated August 27, 2010 (the "Security Agreement"), and recorded with the United States Patent and Trademark Office on September 2, 2010 at Reel/Frame No. 4271/0454, the Grantor granted the Collateral Agent a security interest on certain collateral pledged by Grantor described therein, including without limitation the United States trademark registrations set forth in Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Collateral Agent; and

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, Collateral Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and all right, title and interest of the Collateral Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Collateral Agent agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of Collateral Agent's security interest in the released Trademark Collateral without recourse, representation or warranty and at the Grantor's sole cost and expense.
