TRADEMARK ASSIGNMENT

WHEREAS, pursuant to the terms of corporate restructuring and re-organization, the parties desire to have Funrise assign all of its right, title and interest in and to the Trademark to Honor Metro, together with the goodwill of the business connected with and symbolized by the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as follows:


Funrise hereby assigns, transfers and conveys to Honor Metro the entire right, title, interest in and to the Trademark, together with the goodwill of the business connected with and symbolized by the Trademark.


Funrise authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of Registration No. 1281715 to Honor Metro as assignee of Funrise's entire right, title and interest therein. Funrise agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Honor Metro's ownership of the Trademark.
