THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "Trademark Termination and Release") dated as of December 28, 2012, from WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (the "Bank") pursuant to (1) a Grant of Security Interest dated as of October 3, 2002 (the "Grant") between NEW BELGIUM BREWING COMPANY, INC. (the "Grantor") and the Bank, (2) an Amendment to Grant of Security Interest dated as of June 20, 2006 ("the "First Amendment to Grant") between NEW BELGIUM BREWING COMPANY, INC. WHEREAS, the Bank now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. <u>Definitions</u>. 
