TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this “**Release**”), is entered into as of January 25, 2013 by **FIFTH STREET FINANCE CORP.**, a Delaware corporation with a place of business at 10 Bank Street, 12th Floor, White Plains, New York 10606 (the “**Administrative Agent**”), in connection with the grant of security interests in the Trademark Collateral (as defined below) held by **WELOCALIZE, INC.**, a Delaware corporation with a place of business at 241 East 4th Street, Suite 207, Frederick, Maryland 21701 (“**Grantor**”), in favor of the Administrative Agent.

WITNESSETH:

WHEREAS, Grantor had entered into that certain Trademark Collateral Assignment and Security Agreement with the Administrative Agent, dated as of November 19, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the “**Trademark Agreement**”) which was recorded in the Trademark Division of the United States Patent and Trademark Office on December 14, 2010 at Reel 004433, Frame 0471, for the purpose of providing certain trademarks and trademark applications as collateral security for the payment and performance of certain obligations of Grantor to the Administrative Agent, including, without limitation, the trademarks and trademark applications set forth on Schedule A attached hereto; and

WHEREAS, Grantor has requested that Administrative Agent release the entirety of its security interests in and lien on the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. **Definitions.** The term “**Trademark Collateral**”, as used herein, shall mean all of Grantor’s right, title and interest of every kind and nature as of the date hereof in all of Grantor’s trademarks (including, without limitation, those trademark registrations and trademark applications listed on Schedule A attached hereto).

2. **Release of Security Interest.** The Administrative Agent hereby terminates, cancels, releases and discharges all of its security interests in the Trademark Collateral and hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by the Administrative Agent, all of said Administrative Agent’s right, title and interest in and to the Trademark Collateral.


3. **Further Assurances.** The Administrative Agent agrees to take such further action as may be reasonably requested by Grantor, from time to time, at Grantor’s expense, to effectuate and carry out the provision and intent of this Release.
