TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 21, 2012 by Wells Fargo Bank, National Association ("Wells Fargo").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 18, 2008 (the "Original Agreement"), by and between Sure Fit Inc. (formerly known as Sure Fit Acquisition Inc.), a Delaware corporation (the "Company") and Wells Fargo, the Company granted to Wells Fargo a security interest in all of its right, title and interest in and to the Trademarks (as defined in the Original Agreement), including without limitation, the Trademarks set forth on Exhibit A hereto; and

WHEREAS, pursuant to that certain Amended and Restated Trademark Security Agreement, dated as of December 29, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "Amended and Restated Agreement") by and between the Company and Wells Fargo, which amended and restated the Original Agreement in its entirety, the Company granted to Wells Fargo a security interest in all of its right, title and interest in and to the Trademarks (as defined in the Amended and Restated Agreement), including without limitation, the Trademarks set forth on Exhibit A hereto; and

WHEREAS, the Original Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 24, 2008 at Reel 3858, Frame 0281; and

WHEREAS, the Amended and Restated Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 7, 2010 at Reel 4237, Frame 0967; and

WHEREAS, the Company has requested that Wells Fargo release its security interest in the Trademarks and reassign the same to the Company. Capitalized terms used herein without definition are used as defined in the Amended and Restated Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Wells Fargo hereby releases its security interest in all of the Company's right, title and interest in and to the Trademarks, including without limitation, the Trademarks set forth on Exhibit A hereto.

2. Wells Fargo hereby reassigns, grants and conveys to the Company, without any representation, recourse or undertaking by Wells Fargo, all of Wells Fargo's right, title and interest in and to the Trademarks.


