**FIRST AMENDMENT TO THE
OPERATING AGREEMENT OF
SOVAREDFERN LLC**

This First Amendment (the "*First Amendment*"), to the Operating Agreement dated June 12, 2012 (the "*Operating Agreement*") of SOVAREDFERN LLC (the "*Company*"), dated October 29, 2012 by the undersigned Members of the Company (the "*Members*"). Capitalized terms not defined herein, shall have the meaning set forth in the Operating Agreement.

WHEREAS, pursuant to Section 10.4 of the Operating Agreement, the Operating Agreement may be amended with the consent of the Members; and

WHEREAS, the Members hereby consent and agree that all other terms and conditions set forth in the Operating Agreement shall remain unchanged and each Member hereby agrees to be bound by the terms and conditions set forth in the Operating Agreement, a copy of which is attached hereto as *Exhibit A*, and this First Amendment.

NOW THEREFORE, the Members hereby amend the Operating Agreement as follows:

1. Section 2.5 of the Operating Agreement is hereby deleted in its entirety and replaced with the following:

2.5. Principal Office. The principal office and place of business of the Company in the State of Georgia shall be located at 705 Town Blvd NE #612, Atlanta, GA 30319 or at any other place within the State of Georgia which the Manager selects.

2. Section 2.6 of the Operating Agreement is hereby deleted in its entirety and replaced with the following:

2.6. Resident Agent. The name and address of the Company's resident agent in the State of Georgia shall be Sam Sova, 705 Town Blvd NE #612, Atlanta, GA 30319.

3. The following shall be added to the Operating Agreement as Section 6.6.1:

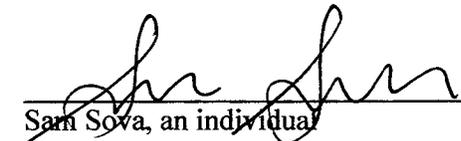
6.1.1 Managers. The Company shall be managed by Managers, who may, but need not, be a Member. Sam Sova is hereby designated to serve as the Manager. Those Persons acting as Manager may act independently of one another and without the approval of the other Persons acting as Manager, unless otherwise stated herein this Agreement. A Manager may only be removed by unanimous vote of all of the Members.

4. The following shall be added to the Operating Agreement as Section 6.6.2:

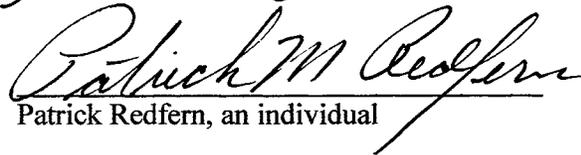
6.1.2 Except as otherwise provided in this Agreement, the affirmative vote of members holding fifty-one percent (51%) or more of the Percentages then held by Members shall be required to approve any matter coming before the Members, including the appointment of Managers.

RESOLVED, that the Members of the Company hereby approve the sale of any and all interest owned in the Company by Chad Redfern to the Patrick Redfern.

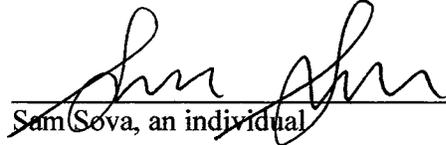

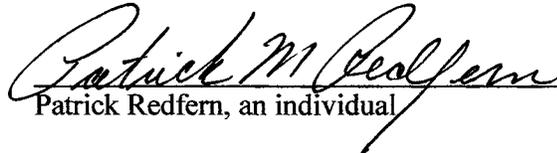
