## **TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (the "Agreement") is made this day the 29th of January, 2013 (the "Effective Date") by and between Patrick Weir (the "Assignor") and Jim Box, Inc. (the "Assignee").

WHEREAS Assignor has adopted, used, and is using the mark further described in Schedule A attached hereto and incorporated by reference, which was registered in the United States Patent and Trademark Office ("Mark");

WHEREAS Assignor seeks to transfer the Mark and the registration to Assignee, who intends to use the Mark in interstate commerce for the "Manhattan Mailroom" business following the purchase of certain assets from Patrick Weir;

NOW, THEREFORE, for good and valuable consideration of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby grants, transfers, assigns, and conveys to Assignee, its successors and assigns, all right, title, and interest in the Mark, including but not limited to ownership, the registration, the goodwill of the business symbolized by the Mark, and the right to maintain a registration on the Mark in Assignee's name as claimant;
2. Whether the trademark on the Mark shall be preserved or maintained in the United States of America, shall be at the sole discretion of the Assignee;
3. Assignor hereby confirms that Assignee and his successors and assigns shall own all right, title, and interest in the Mark;
4. Assignor agrees to execute any and all documents necessary to transfer the rights in the Mark, registration, and goodwill to Assignee and perfect Assignee's ownership of trademark rights;
5. Assignor further agrees that if Assignee is for any reason unable to secure Assignor's signature on any document regarding the Marks, with respect to which Assignor's signature is required, then Assignor hereby irrevocably designates Assignee and Assignee's duly authorized officers as agents to execute and file such documents and to do all other lawfully permitted acts to further the issuance of such registrations with the same legal force and effect as if executed by Assignor;
6. This Agreement constitutes the entire agreement between the Parties hereto, and supersedes any prior or written agreement or understanding between the Parties; and

7. This Agreement has been interpreted under the United States Trademark Laws, but shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles.

IN WITNESS WHEREOF and intending to be legally bound by, the Parties have hereunder agreed on the Effective Date set forth above.
