TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment Agreement") is made as of January 24, 2013 by and among THQ Inc., a Delaware corporation ("THQ"), THQ Wireless Inc., a Delaware Corporation ("THQ Wireless"), Volition, Inc., a Delaware corporation ("Volition"), Vigil Games, Inc., a Texas corporation ("Vigil") (collectively, THQ, THQ Wireless, Volition and Vigil "ASSIGNORS") and KMA Acquisitions, LLC, a Delaware limited liability company (hereinafter "ASSIGNEE"). ASSIGNORS and ASSIGNEE are sometimes herein referred to collectively as the "Parties" and each individually as a "Party."

WHEREAS, ASSIGNORS and ASSIGNEE entered into a certain Asset Purchase Agreement dated as of January 23, 2013 (the "APA");

WHEREAS, pursuant to the APA, ASSIGNORS agreed to convey their entire right, title and interest in, to, and under the United States and foreign trademark registrations and trademark applications listed in the Trademark Assignment Schedule attached hereto to ASSIGNEE; and

WHEREAS, ASSIGNORS and ASSIGNEE wish to enter into this Assignment Agreement for the sole purpose of confirming and memorializing the applicable terms of the APA, and making said terms of record in the U.S. Patent and Trademark Office and foreign trademark offices.

FOR GOOD AND VALUABLE CONSIDERATION set forth in the APA, the receipt and sufficiency of which are hereby acknowledged, ASSIGNORS and ASSIGNEE hereby agree:

ASSIGNORS hereby confirm that they hereby sell, assign, and transfer to ASSIGNEE, its successors and assigns, all of ASSIGNORS' right, title, and interest in, to and under the marks set forth in Trademark Assignment Schedule, and all applications, registrations, and renewals for any of the foregoing, together with the goodwill associated with and symbolized by each of the foregoing, and including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the marks (collectively, the "Transferred Marks"). The Transferred Marks are being assigned, and such applications therefor, are being transferred.

ASSIGNORS hereby agree and undertake to execute, whenever requested by ASSIGNEE, all documents and to take such further actions that are reasonably deemed necessary for ASSIGNEE's securing, prosecuting and maintaining all of the Transferred Marks, with all actual costs being paid by ASSIGNEE, but without any further compensation to ASSIGNORS.

ASSIGNORS hereby authorize and request the U.S. Patents and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record ASSIGNEE as the owner of the Transferred Marks.

This Assignment Agreement shall be governed by the laws of the state of Delaware. Notwithstanding anything to the contrary herein, in the event of any conflict or inconsistency between the terms of this Assignment Agreement and the terms of the APA, the terms of the

APA will prevail, and nothing contained herein shall be deemed to alter, modify, expand or diminish the terms of the APA.




