RELEASE OF SECURITY INTEREST

Michael's Enterprises, Inc., ("Michaels"), a Mississippi corporation, having a place of business at 230 River Commons Circle West, Memphis, TN 38120, entered into a PROMISSORY NOTE AND SECURITY AGREEMENT (the "Security Agreement") with Back Yard Burgers, Inc. ("Back Yard Burgers"), a Delaware Corporation whose principal office is located at 500 Church Street, Suite 200, Nashville, TN 37219, and such Security Agreement was effective on November 2, 2010. Such Security Agreement created a security interest in U.S. Federally Registered Trademark "MIZ GRAZI'S", Registration Number 2,024,782, for "hot sauces, spices and relishes" (the "Mark").

On November 22, 2010, Michaels caused the above mentioned Security Agreement and security interest to be recorded with the United States Patent and Trademark Office at Reel/Frame 004420/0075 - 004420/0082. Michaels hereby acknowledges that Michaels' above mentioned Security Agreement has been satisfied (including any security interest granted pursuant to the Security Agreement), and Michaels hereby terminates the Security Agreement and releases Back Yard Burgers, and the above identified Mark, from such security interest, and Michaels does hereby authorize and direct that the above mentioned security interest be discharged of record.
