

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record the TRADEMARK as property of ASSIGNEE; and


ASSIGNOR further agrees to execute such further documents as may be required to records ASSIGNEE as the owner of the TRADEMARK.
