Assignment Agreement (Trademarks)

THIS ASSIGNMENT AGREEMENT ("Agreement") is made as of the Effective Date (as defined below) between:

- (1) **Syngenta Crop Protection AG**, a company duly organized and existing under the laws of Switzerland, having its registered offices at Schwarzwaldallee 215, 4058 Basel, Switzerland, (hereinafter "Assignor"), and
- (2) **Syngenta Participations AG**, a company duly organized and existing under the laws of Switzerland, having its registered offices at Schwarzwaldallee 215, 4002 Basel, Switzerland, (hereinafter "Assignee").

WHEREAS, Assignor has acquired certain intellectual property rights with effect as of October 1, 2012 as per a separate Agreement and Assignor is herewith assigning legal title to certain trademarks to Assignee with an assignment effective date as of 8th January 2013 ("Effective Date").

NOW IT IS AGREED as follows:

1. DEFINITIONS

In this Agreement unless the context otherwise requires:

"the "Transferred Trademarks" means the trademark rights of record in the United States Patent and Trademark Office and of certain foreign counterparts set forth on Exhibit 1 to Schedule A hereto and all goodwill associated therewith.

2. ASSIGNMENT

The Assignor HEREBY ASSIGNS to the Assignee, and free from all liens, charges, security, licenses and other encumbrances whatsoever, title to the Transferred Trademarks, including all rights, powers, liberties, immunities and advantages attaching to them. Assignee accepts such assignment.

3. FURTHER ASSURANCE

The Assignor HEREBY COVENANTS to the Assignee that the Assignor will:

- 3.1 execute any document or do any act or thing which may be reasonably necessary under the law of any country for completing the transfer to the Assignee of legal title to the Transferred Trademarks assigned by Clause 2 above, including without limitation entering into any confirmatory documentation as the Assignee may reasonably require to promptly register the rights assigned herein on all the appropriate registers or otherwise enjoy the full benefit of the property and rights hereby assigned;
- 3.2 at the request of the Assignee, at its own expense, send to the Assignee by courier, as soon as reasonably practicable, a complete copy of the Assignor's prosecution file for each of the Transferred Trademarks;
- 3.3 instruct its agents, as of the Effective Date, to direct all correspondence regarding the Transferred Trademarks to the Assignee.

4. SEVERABILITY


If any provision of this Agreement is declared to be invalid or unenforceable by any competent court, the remaining portions or provisions of this Agreement nevertheless remain in full force and effect. The Parties shall, in that case, use their best efforts to negotiate substitute provisions for those declared invalid or unenforceable, in order to carry out the intent and the purpose of this Agreement.

5. GOVERNING LAW


This Agreement shall be governed by and construed in accordance with the substantive laws of Switzerland, without giving effect to the conflict of laws provisions thereof. The parties hereby submit to the exclusive jurisdiction of the competent courts of the city of Basel.




