## **CONFIRMATORY TRANSFER OF SECURITY INTEREST**

WHEREAS, COMMUNICATION CABLES, LLC, a Delaware limited liability company, 135 Crossways Park Drive, Suite 101, Woodbury, New York, 11797, (hereinafter, "CABLES") is the owner of the Trademarks and the corresponding United States Trademark Registrations and Applications as shown on the attached Exhibit A (hereinafter, the "TRADEMARKS"); and

WHEREAS, pursuant to a Trademark Security Agreement dated September 7, 2012, OCM FIE, LLC, a Delaware limited liability company, with a business address at c/o Oaktree Finance, LLC, 1301 Avenue of the Americas, 34<sup>th</sup> Floor, New York, NY 10019, (hereinafter, "OCM"), acting as Agent for Lenders identified in the Trademark Security Agreement, was assigned a security interest in the TRADEMARKS, said assignment recorded with the U.S. Patent and Trademark Office at Reel 4864 at Frame 0422; and

WHEREAS, on January 7, 2013, pursuant to a Successor Agent Agreement between WILMINGTON TRUST, NATIONAL ASSOCIATION of 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402, (hereinafter, "WILMINGTON"), OCM, CABLES and its related companies, OCM resigned as Agent and transferred all of its rights and privileges under the Trademark Security Agreement to WILMINGTON; and

WHEREAS, CABLES, OCM and WILMINGTON desire to document the transfer of the security interest in the TRADEMARKS.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, OCM hereby acknowledges and confirms that effective January 7, 2013, OCM transferred and assigned to WILMINGTON the related security interest in the trademarks as fully and entirely as the same would have been held by OCM had this transfer not been made.

IN WITNESS WHEREOF, OCM, intending to be legally bound, has caused this CONFIRMATORY TRANSFER OF SECURITY INTEREST to be executed as of the 30 day of January, 2013.
