Release of Intellectual Property Security Agreement

This Release is executed as of January 31, 2013, by ING BANK N.V., as security agent for the Senior Finance Parties (the "**Security Agent**"); for the benefit EVAC INTERNATIONAL OY, a private company with limited liability incorporated under the laws of Finland ("**EFI**") and EVAC OY, a private company with limited liability incorporated under the laws of Finland ("**EFH**") and together with EFI, each a "**Grantor**" and collectively the "**Grantors**".

WITNESSETH:

WHEREAS, pursuant to a Short-Form Intellectual Property Security Agreement dated as of December 20, 2007 (the "**IP Security Agreement**") among the Grantors and the Security Agent, which IP Security Agreement was recorded in the Office on January 2, 2008, at Reel 3688, Frame 0030, the Grantors have granted a security interest in its right, title and interest in and to the intellectual property listed in Schedule 1 and any rights in relation thereto (the "**Intellectual Property**") to the Security Agent, for the benefit of the Senior Finance Parties. Any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the applicable IP Security Agreement.


WHEREAS, in connection with a "Third Party Disposal" (as defined in the Senior Facilities Agreement), the Security Agent has agreed to release the security interests created under the IP Security Agreement, on the terms and conditions set forth in that certain Termination and Release of US Security Interests dated as of the date hereof, between the Security Agent, the Grantors and certain other parties thereto.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent, acting on behalf of the Senior Finance Parties, hereby unconditionally and irrevocably releases the security interests over the Intellectual Property Collateral (as defined in the IP Security Agreement) created by the IP Security Agreement, including the items listed on Schedule 1 hereto.

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.


