The Commissioner for Trademarks in the United States Patent and Trademark Office, as well as each equivalent governmental authority in any other jurisdiction throughout the world, is requested to record this Assignment.

This Trademark Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument.
