WHEREAS, Assignee desires to acquire the entire right, title, and interest in and to the Mark and the Registration;



Assignor hereby irrevocably appoints Assignee as its attorney-in-fact, effective as of the date hereof, with full right of substitution for the purpose of executing such documents and taking such other actions. This attorney-in-fact shall be for the benefit of Assignee, its licensees, successors, and assigns, and is coupled with an interest.
