
TRADEMARK ASSIGNMENT

WHEREAS, DSS Rapak, Inc., a corporation organized and existing under the laws of the State of Delaware, with a principal place of business at 1201 Windham Parkway, Suite D, Romeoville, IL 60446 (hereinafter "ASSIGNOR"), has adopted, used and is using, and is the owner of the United States Trademark Registration 2,695,936 which was registered on Mar. 11, 2003 (which resulted from United States Trademark Registration Application Serial No. 78/134,513 filed on June 10, 2002), for the trademark **EVACUFILM.**

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, ASSIGNOR, does hereby sell, assign, transfer, and set over unto ASSIGNEE, all rights, title and interest in and to United States Trademark Registration 2,695,936, all rights associated with said trademark, and all of the goodwill of the business symbolized by said trademark.

THE PRESENT ASSIGNMENT includes all rights and interest associated with the trademark, including ASSIGNOR'S common law rights, the right to sue for and collect for past trademark infringement and the right to claim prior use of the mark by ASSIGNOR as a basis for federal and/or state trademark registration. In addition, any continued use by ASSIGNOR of any of the marks shall inure to the benefit of the ASSIGNEE.
